As part of her report, Allen reported that on any given week, more than 500 new resident students access their services, which consists of four different settlement and language programming streams.

# **COMMUNITY QUESTION PERIOD:**

#### REDEVELOPMENT OF 638 PRINCESS AVENUE

Mr. Doug Derouin appeared before City Council regarding the redevelopment of 638 Princess Avenue. Mr. Derouin referred to the increased costs of the redevelopment due to the addition of the multicultural and youth centre components and enquired if the original budgeted amount would be sufficient without same. He also noted that many community centres were underutilized and enquired if the use of same for the multicultural and youth centre components could be considered.

# **ENQUIRIES:**

# (288) EXTENSION OF BUS SERVICE TO ACCOMMODATE EXTENDED SUNDAY SHOPPING HOURS

Councillor Rice enquired if the potential cost of providing Sunday bus service to accommodate the extended Sunday shopping hours could be provided.

At the request of Her Worship the Mayor, Tim Sanderson, the Director of Transportation Services responded that the cost to operate 5 buses from 8:00 a.m. to 7:00 p.m. on Sundays and Statutory Holidays was estimated to be \$286,000 per year, exclusive of any off-setting revenue. He noted that provincial funding would cover 50 per cent of those costs and revenue was expected to be \$20,000 per year, leaving approximately \$140,000 to \$150,000 in annual costs to the City of Brandon.

# (289) RECYCLING DEPOT AT 34TH STREET AND VICTORIA AVENUE

Councillor Berry advised that the dumping of inappropriate items at the recycling depot at 34th Street and Victoria Avenue continued to be a problem. He enquired if larger, more visible signs, inclusive of the maximum fine for littering could be considered.

At the request of Her Worship the Mayor, the City Manager responded that the new signage would be installed in the very near future.

# (290) UPDATE ON EASTERN ACCESS ROUTE

Councillor Isleifson requested an update on the Eastern Access Route.

At the request of Her Worship the Mayor, the City Manager responded that a report from Manitoba Infrastructure and Transportation (MIT) in July 2012 had indicated that, barring any unforeseen circumstances, the Eastern Access Route was expected to be open to traffic by the end of November 2012.

#### (291) UPDATE ON PIPELINE CONSTRUCTION ON 33RD STREET EAST

Councillor Isleifson enquired when the pipeline construction was expected to be completed and 33rd Street East re-opened to traffic.

At the request of Her Worship the Mayor, the City Manager responded that the pipeline work to connect the City of Brandon's main wastewater pumping station to the new reclamation facility at 65th Street East was expected to be completed by the end of September 2012.

# (292) GIFT-IN-KIND CONTRIBUTION TO DISPLAY BUILDING NO. II RESTORATION PROJECT

Councillor Harwood noted that at a previous meeting City Council had agreed to provide a gift-in-kind contribution to the Provincial Exhibition of Manitoba for their Display Building No. II Restoration Project. He requested an update on the status of same, inclusive of the attached dollar value.

At the request of Her Worship the Mayor, the City Manager advised that a report on this issue would be provided at the September 17, 2012 City Council meeting.

# (293) NORTH HILL TRAFFIC AND PARKING CONCERNS

Councillor Fawcett enquired if the no parking area on the northwest side of Cater Drive could be extended to Pilling Drive; larger pedestrian crossing signs at Kirkcaldy Drive and 3rd Street North could be considered; and, the existing pedestrian crossing at the intersection of Braecrest and Knowlton Drives be studied further.

Her Worship the Mayor agreed to take this matter under advisement.

#### (294) BROWNFIELD DEVELOPMENT INCENTIVE PROGRAM

Councillor Roberts noted that there were a number of brownfields and large vacant buildings within the City of Brandon. He enquired if an incentive program involving increased taxes or additional fees on such properties could be considered with the funds raised to be used for clean-up and green space enhancement.

Her Worship the Mayor agreed to take this matter under advisement.

# (295) ACCEPTABLE FIRE PITS

Councillor Chaboyer noted that she had received complaints regarding the improper use of fire pits within the City of Brandon. She enquired if an awareness campaign could be launched, inclusive of the regulations for fire pits within the City and the required permits for same.

At the request of Her Worship the Mayor, the City Manager agreed to work with the Director of Communications to ensure that the information was made available in the media and on the City's website.

#### (296) SKATEBOARDING ON SIDEWALKS

Her Worship the Mayor enquired if the use of skateboards on city sidewalks was prohibited and if so, what the fines were for non-compliance.

At the request of Her Worship the Mayor, the Chief of Police responded that skateboard use on sidewalks was in violation of the City of Brandon Traffic By-law, however tickets were issued only to repeat offenders. He agreed to launch a media campaign advising the public that is was illegal and the reasons why.

# (297) IMPACT OF THE IRRIGATION PROJECTS AT RIVERS, MANITOBA ON THE CITY OF BRANDON'S WATER SUPPLY

Councillor Chaboyer requested information on the potential impact of the irrigation projects at Rivers, Manitoba on the City of Brandon's water supply.

Her Worship the Mayor responded that a report on same would be provided by the City of Brandon's members of the Assiniboine Hills Conservation District.

AND WHEREAS the Federation of Canadian Municipalities (FCM) has launched a campaign to ensure the new plan reflects municipal priorities across the country and asks its member municipalities to pass a Council resolution supporting the campaign;

AND WHEREAS the City of Brandon has continuing infrastructure needs that can only be met through the kind of long-term planning and investment made possible by a national plan;

NOW THEREFORE BE IT RESOLVED that the Council of the City of Brandon hereby endorses the FCM campaign and urges The Honourable Denis Lebel, Minister of Transport, Infrastructure and Communities to work with FCM to ensure the new long-term infrastructure plan meets the core infrastructure needs of cities and communities and that the new long-term plan is fully in place when existing programs expire in 2014; and
