#### ADOPTION OF AGENDA:

#### Harwood-Rice

#### (A) PATRICK PULAK - 2012 PUBLIC WATER SUPPLY QUARTERLY REPORT

The Deputy Director of Engineering Services and Water Resources, Patrick Pulak addressed City Council on the 2012 Public Water Supply Quarterly Report submitted with his report dated October 12, 2012.

#### ENQUIRIES:

#### (313) <u>2012-2013 FUNDS FOR COMMUNITY CENTRES' WINTER ACTIVITIES</u>

Councillor Berry enquired if funds had been budgeted to assist Community Centres with the costs incurred for a caretaker/icemaker for the winter months.

At the request of Her Worship the Mayor, the City Manager responded that approximately \$1600 per Centre was available for the remainder of 2012 with a request being put forth for the continuation of the program in the 2013 City of Brandon Budget.

#### (314) QUARTERLY REPORT ON ACCOMMODATION TAX

Councillor Berry enquired when the first Quarterly Report on the Accommodation Tax Fund was expected to be available, and further, whether or not any applications for access to those funds had been received.

At the request of Her Worship the Mayor, the General Manager of Corporate Services indicated that the first payments were due October 20, 2012 with an update on same to be provided shortly thereafter. He advised that one formal application had been received with two more expected in the near future.

#### (315) PROVINCE OF MANITOBA CUTBACKS ON OVERNIGHT SNOW CLEARING CREWS

Councillor Harwood referred to a recent newspaper article regarding Manitoba Infrastructure and Transportation having eliminated the overnight snow clearing crews on Manitoba highways and enquired if this issue could be discussed with the Province of Manitoba.

Her Worship the Mayor agreed to take this matter under advisement.

#### (316) <u>UPDATE ON THE SOLID WASTE COLLECTION SYSTEM</u>

Councillor Fawcett requested an update on the Solid Waste Collection System which had been in operation since 2007.

At the request of Her Worship the Mayor, the City Manager stated that, although the population had risen by approximately 11 per cent since 2007, the sanitation operating budget had remained about the same; the need for new landfill cell development had been reduced to every 5 years from every 2 years; waste diversion had increased from 17 per cent in 2008 to 43 per cent in 2011; and residential waste had decreased from 18,000 tons in 2007 to 14,000 tons in 2011. He added that the launch of the Organic Collection System for 5500 residences combined with a projected increase in recycling by residents was expected to increase the landfill lifecycle by approximately 6 years with the savings from same estimated to be \$37,000 per year. He also noted that the creation of a permanent Household Hazardous Waste Depot was planned for 2013.

#### (317) <u>9TH STREET AND ABERDEEN AVENUE INTERSECTION</u>

Councillor Montague advised that the intersection at 9th Street and Aberdeen Avenue continued to be a problem for area residents and enquired if changes to its design could be considered.

Councillor Chaboyer added that the complaints she had received were in regards to the roadway not being wide enough to make the turn off 9th Street onto Aberdeen Avenue.

At the request of Her Worship the Mayor, the City Manager replied that, following research regarding the number of accidents and the traffic volume at that intersection, the Engineering Department had concluded that design changes were not warranted at this time. He advised that the intersection had been specifically designed to calm and slow down traffic, however, the situation would be monitored and changes made if necessary.

#### (318) <u>CITIZEN ENGAGEMENT - BUDGET PROCESS</u>

Councillor Chaboyer enquired if a plan was in place to allow for more citizen engagement in the budget process, inclusive of round table discussions and priority lists.

At the request of Her Worship the Mayor, the City Manager mentioned that this item would be discussed at upcoming budget planning meetings.

#### (319) SOLID WASTE COLLECTION BY-LAW - EDUCATION AND ENFORCEMENT

Councillor Chaboyer enquired how residents were being educated on the new Solid Waste Collection By-law and its enforcement.

At the request of Her Worship the Mayor, the General Manager of Operational Services explained that an advertising campaign was underway advising residents of the changes and same would continue well into the future. He advised that written notice was being given to homeowners who failed to remove the bins from the lane. He added that staff were prepared to work with homeowners on an individual basis if necessary and that the issuance of tickets and fines would be a last resort.

#### ANNOUNCEMENTS:

#### SOUTH CENTRE WARD MEETING - NOVEMBER 29, 2012

Councillor Rice announced that a South Centre Ward Meeting would take place November 29, 2012 at 7:00 p.m. at the Central Community Centre. He advised that items to be discussed would include the 2013 City of Brandon Budget; age-friendly Brandon; and any other city and ward issues.

#### 17TH STREET EAST AND RICHMOND AVENUE EAST TRAFFIC LIGHTS

Councillor Chaboyer noted that the installation of traffic lights at the intersection of 17th Street East and Richmond Avenue East was being considered and thanked the Development Services Division for their efforts in this regard.

#### RIVERVIEW WARD MEETING - OCTOBER 23, 2012

Councillor Isleifson announced that a Riverview Ward meeting would take place on October 23, 2012 at 7:00 p.m. at the East End Community Centre. He advised that agenda items would include the Rideau Park Recreation Hub; Age-friendly Brandon consultations; the Environmental Strategic Plan; ward infrastructure issues; the 2013 City of Brandon Budget; the solid waste collection system; and any other city and ward issues.

#### FIRE CHIEF FOR A DAY

Councillor Blight announced that he had been pleased to represent City Council at the recent Fire Chief for a Day Event where local Grade 4 students spent the day at the No. 1 Fire Hall and the Emergency Services College.

(A) INITIATION OF ZONING BY-LAW AMENDMENT PUBLIC OUTREACH <u>REQUIREMENTS</u>

City Council considered a report from the Director of Planning dated October 5, 2012 with respect to the above.

That the City of Brandon initiate an amendment to its Zoning By-law to include in the by-law a section on public outreach requirements and processes in accordance with the policies set-forth in Section 10.2.6 of proposed Brandon and Area Planning District Development Plan By-law No. 95/01/12. CARRIED.

#### (B) INITIATION OF AMENDMENT TO APPENDIX "C" OF ZONING BY-LAW NO. 6642 -URBAN DESIGN STANDARDS AND GUIDELINES

Submitted for consideration was a report from the Director of Planning dated October 5, 2012 with respect to the above.

That the City of Brandon initiate an amendment to the City of Brandon Zoning By-law No.6642, Appendix "C" City of Brandon Urban Design Standards and Guidelines, in order to update the urban design standards and guidelines to create a more effective and user-friendly document. CARRIED.

## (C) TRANSFER OF FUNDS FROM LAND ACQUISITION RESERVE DEMOLITION OF FORMER BRANDON INN HOTEL

Considered was a report from the General Manager of Development Services dated October 5, 2012 with respect to the above.

That funding in the amount of \$538,000.00 be transferred from the Land Acquisition Reserve to the Development Services Operating Account for the removal and disposal of the hazardous building materials from the former Brandon Inn Hotel. CARRIED.

#### (D) TENDER - CONTRACT B UNDERGROUND WORKS

Councillor Rice declared a conflict of interest due to his employment in the construction industry and retired from the Council Chamber without any further discussion.

City Council considered a report from the General Manager of Development Services dated October 2, 2012 with respect to the above.

#### Harwood-Chaboyer

That the low bid of Allen & Bolack Excavating Ltd. to carry out the Contract B Underground Works as per tender and specifications at a cost of \$ 336,354.71 (including GST) be accepted. CARRIED.

#### (E) FUNDING OF ASPEN DRIVE WATERMAIN OVERSIZING COSTS FROM DEVELOPMENT RESERVE
