MINUTES OF THE SPECIAL MEETING OF CITY COUNCIL HELD ON SATURDAY, JANUARY 12, 2013 AT 9:20 AM IN THE COUNCIL CHAMBER, CIVIC ADMINISTRATION BUILDING, BRANDON, MANITOBA

"Your Worship, notice of this meeting was provided to all members of City Council advising that a Special Meeting of City Council would be held this date to deliberate the City's 2013 Operating and Capital Budgets."

The City Clerk confirmed that in view of the above compliance and there being quorum, it was lawful to proceed with this Special Meeting.

The City Clerk explained that such motions could only state a change to the 2013 budgets. He indicated that the suggestion to defer the expenditure to the following budget year would be duly noted by Administration for consideration when preparing the 2014 budgets.
