NO. 6973 TO CLOSE AND CONVEY THE PUBLIC LANE IN PLAN 1701 BLTO LOCATED ADJACENT TO KASIURAK BAY AMENDMENT, 2ND AND 3RD READINGS

That By-law No. 6973 to close a portion of the public lane in Plan 1701 BLTO located on Kasiurak Bay and convey same to the adjacent property owner be amended as follows:

- (a) by adding in the introductory paragraph, after the word: "close", the words: "portion of" and by deleting the words: "property owners" and substituting therefor, the words: "property owner";
- (b) by deleting the description in Clause 1.(a) and substituting the following therefor:

(b) That title to all that portion of public lane described in Clause 1.(a) excepting thereout all mines and minerals and other matters set forth in the Crown Lands Act, shall be conveyed to the property owner of Lot 12, Block 14, Plan 1701 BLTO for the sum of \$2,805.00 plus Goods and Services Tax and other valuable considerations."; and
