 - (A) ACCOMMODATION TAX FUNDING REQUEST CROCUS PLAINS HIGH SCHOOL HOCKEY

(E) APPLICATION TO SUBDIVIDE - 1215 & 1225 PATRICIA AVENUE AND 2051 TRACEY STREET

- submitting written confirmation to the Department that arrangements have been made for an easement agreement and Plan of Easement to the satisfaction of Manitoba Hydro, and registering the easement agreement along with the easement plan, if required, in series immediately following registration of the subdivision; and
- 4) submitting written confirmation to the Department that the Brandon School Division has received \$12,352.50 as a cash-in lieu contribution for school purposes.

(F) <u>INCREASE TO MOVING ALLOWANCE UNDER THE RESIDENTIAL TENANCIES ACT</u>
