Mr. Barry Wowk, President of the Manitoba Senior Baseball League appeared before City Council with respect to the repayable loan from Brandon City Council to help the Senior Baseball League regain its financial footing. He presented City Council with a cheque in the amount of \$10,000 as repayment of the loan and thanked City Council for its support.

# (C) <u>CONDITIONAL USE APPLICATION - 354 - 11TH STREET (SIGURDSON/WILKS)</u>

City Council sat to receive representation on the appeal of the Planning Commission's decision to approve the conditional use application of Candace Sigurdson on behalf of Kelly Wilks for 354 - 11th Street.

Candace Sigurdson appeared on behalf of the applicant in support of the application. She noted that the original application had been modified to reduce the number of boarders from 7 to 6.

Jenni Kroeker, a resident of the area, appeared before City Council in opposition to the conditional use application. She noted that the intended use was really a rooming house and not a boarding house as stated in the application as the owners of the property did not live in the home. Ms. Kroeker stated that the area was already over populated and parking and noise were an issue.

At the request of His Worship the Mayor, Steve McMillan of Planning Services appeared before City Council to provide clarification and background information on the conditional use application.

No further representation was put forward either in support of or in opposition to the conditional use application.

CHAIRMAN: Mayor Dave Burgess brought the meeting to order at 3:05 pm.

Councillor Blight moved to adopt the agenda as presented. Carried.

#### 2008 Audited Financial Statement

Ms. Millis presented the 2008 Audited Financial Statement to the Committee. She briefly outlined the guidelines used to audit the City of Brandon's financial statement which includes the responsibilities of the auditor, the overall auditing strategy, and the amount of materiality determined. BDO performs a series of tests to check the accuracy of the City's financial accounting systems. These tests showed that the current accounting system used by the City of Brandon provides accurate financial information and has satisfactory controls built in. She also stated that the financial statements are fairly stated in accordance with Generally Accepted Accounting Principles. One minor matter with respect to a potential understatement of the accured vacation liability due to an incorrect wage rate was brought to the Committee's attention. An unqualified audit report has been issued to the City of Brandon for the year ended December 31, 2008.

Councillor Blight moved to accept the 2008 Financial Statement and to present it to City Council. Motion carried.

Ms. Millis retired from the meeting.

Councillor Blight moved to adjourn the meeting at 3:25 pm. Carried.

(B) KEYSTONE CENTRE VERBAL REPORT MAY 19, 2009

Mayor and Councillors City of Brandon

Councillor Fitzpatrick provided a report to City Council on the upgrades to the Keystone Centre in preparation for the 2010 Memorial Cup. He noted that construction had begun on the five luxury suites in the Westman Place arena and would continue for the next 4 to 5 months, and that the video scoreboard had been ordered and was expected to be installed in mid August. He advised that tenders had been received for the renovations to the upper concourse which included replacing the roof, installation of an HVAC system, and electrical upgrades.

Councillor Fitzpatrick further reported that the Keystone Centre was investigating possible integration with the City of Brandon's facility booking system as the number of events held at the Keystone Centre continued to increase throughout the year. He concluded by noting that a \$0 deficit was being budgeted for in 2010, which had not been a realistic expectation in past years.

# (C) JOINT TASK FORCE - BRANDON SCHOOL DIVISION AND CITY OF BRANDON VERBAL REPORT MAY 19, 2009

Mayor and Councillors City of Brandon

Councillor MacCrae provided a verbal report on the recent meeting held on May 5, 2009 between members of City Council and the Brandon School Division Board of Trustees. He extended a thank you on behalf of the School Division to City Council for the continuation of the bus program for Industrial Arts/Home Economic students. Councillor MacCrae noted that dialogue continued on the proposed French Milieu program.

Councillor Blight added to the report by stating that efforts continued to encourage youth representation on City Council whereby he noted that there was a credit available through the school system for youth that participated in same. He further noted that information would be forthcoming shortly on the opportunity to get involved in a plastic bag recycling program.

## (D) JET AIR SERVICE POLICY COMMITTEE VERBAL REPORT

Councillor Paterson reported that a formal committee had not yet been established, however he had been in contact with the President of the Brandon Chamber of Commerce to gauge possible interest in establishing a parallel push to lobby the Federal Government to establish an incentive package to entice air carriers to provide jet service to communities. He noted that the enquiry had met with a favourable response from the Executive of the Chamber of Commerce.

Councillor Jessiman advised that he had received numerous calls from ward residents who raised concerns regarding their having been charged at the landfill site for the disposal of leaves and fallen fruit gathered from city streets and boulevards. He enquired if a more intensive spring and fall clean up could be conducted to alleviate this problem.

#### (605) <u>33RD STREET EAST BEING USED AS A GARBAGE DUMP</u>

Councillor Jessiman noted that 33rd Street East had become a garbage dump with items such as old appliances having been dropped off there. He enquired if same could be investigated and cleaned up.
