Blight-McCrae

That the 2010 Operating and Capital budgets be approved;

and further, that Administration prepare the required Financial Plan in accordance with the above noted budgets. CARRIED AS AMENDED.

 - (b) any such housing not leased shall be owned by the user, such that the land portion is repaid over time and any equity on first sale is shared on a cost-recovery basis for the company; and
 - (c) every opportunity shall be taken to build at cost, and on a wholesale volume basis using innovative design and green techniques." LOST.
