#### **COMMITTEE REPORTS:**

# (A) BRANDON DOWNTOWN DEVELOPMENT CORPORATION VERBAL

JUNE 13, 2011

June 13, 2011 Brandon, Manitoba

Councillor Roberts reported that the Downtown Brandon Business Development Corporation met on June 6, 2011. He advised that a presentation on the Tax Increment Financing program had been given by representatives of the Provincial Government. Councillor Roberts added that the Corporation had also addressed some housekeeping issues regarding 10th Street that would allow the development of the Strand Building to continue.

At the request of the Her Worship the Mayor, the General Manager of Development Services provided a summary of the status of the Brown Block/Strand Building. He advised that the two buildings shared a common wall that required stabilization prior to demolition of the Brown Block and remediation of Strand Building. He further noted that a permit had been issued on June 10, 2011 to begin the stabilization this week and was expected to take 2 weeks to complete.

In a response to an enquiry by Councillor Roberts on the condition of 10th Street, the General Manager of Development Services advised that the existing sink hole had been created by a water service line repair. He noted that once work on the Brown Block was completed, the fence would be brought to the curb line on east side of the street and repair work could start on sink hole. He also advised that the old bowling lanes were inaccessible for inspection at this time, and would be addressed in approximately 3 weeks as the demolition/stabilization work was completed.

Councillor Chaboyer enquired as to the status of the Brown Block site following demolition, whereby it was noted that the lot would be backfilled with gravel to the street elevation but would not be utilized as a parking lot.

# (B) BRANDON MUNICIPAL HERITAGE ADVISORY COMMITTEE VERBAL

Councillor Harwood reported that the Brandon Municipal Heritage Advisory Committee met on June 8, 2011. He advised that plans were underway for the Annual Doors Open event to be held July 16 and 17, 2011. Councillor Harwood noted that to date, there were 11 properties on the tour, and work continued on adding to the list. Councillor Harwood further reported that a subcommittee was working on the development of a military monument at the site of the new Police Services building at 10th Street and Victoria Avenue.

## (C) BRANDON GENERAL MUSUEM AND ARCHIVES INC. VERBAL

Councillor Berry reported that the Brandon General Museum and Archives Inc. Inaugural Dinner and Auction would be held on Thursday, June 16, 2011 at the Victoria Inn commencing with cocktails at 6:00 p.m. and dinner at 7:00 p.m. He noted that tickets for the event were still available at a cost of \$60 each or a table of 8 for \$450. Councillor Berry encouraged everyone to come out and support the museum.

That the verbal reports of the Downtown Brandon Business Improvement Corporation, the Brandon Municipal Heritage Advisory Committee, and Brandon General Museum and Archives Inc. be received. CARRIED.

#### **ENQUIRIES:**

## (90) TENDER OF CONTRACT "A" SUMMER WORK PROJECTS

Councillor Rice enquired as to when the tender for Contract "A" with respect to the summer work projects was expected to be put out.

At the request of Her Worship the Mayor, the City Manager responded that both Contracts "A" and "B" would be tendered within two weeks.

# (91) CONDITION OF WILLOWDALE CRESCENT BETWEEN ELMDALE AND FOREST BOULEVARDS

Councillor Berry noted Willowdale Crescent between Elmdale and Forest Boulevards was in need of repairs and enquired as to when repairs to same were expected.

At request of Her Worship the Mayor, the General Manager of Operational Services responded that the north half of Willowdale Crescent had been repaired and the south half would be inspected and repaired as soon as possible.

#### (92) UPDATE ON RESTRICTION OF SMOKING IN PUBLIC PLACES

Councillor Isleifson referred to a previous enquiry whereby it had been noted that the City of Winnipeg was considering a by-law restricting smoking in public places. He advised that the City of Winnipeg had now passed that by-law and requested an update on the status of same for the City of Brandon.

At the request of Her Worship the Mayor, the City Clerk responded that the matter was currently being investigated with consideration being given to whether the proposed by-law should be applied to both public and private property, and that a report to City Council was expected in the near future.

Further to this issue, Her Worship the Mayor responded that due to the fact that Provincial Legislation existed regarding this issue, she had contacted the Honourable Jim Rondeau, Minister of Healthy Living, Youth and Seniors, with respect to municipal legislative authority. Her Worship added that she had also contacted the City of Winnipeg regarding its recent by-law with the results of both discussions to be included in the report from Administration.

## (93) ADVERTISEMENT OF ASSESSMENT APPEAL PROCESS AND DEADLINES

Councillor McCrae noted that many residents were unaware that the time to appeal their property assessments was in the fall rather than when they received their tax bills in the spring and enquired if additional advertising of same could be considered.

Her Worship the Mayor agreed that additional advertising, inclusive of the deadline for appeals, would be beneficial and should take place in early fall prior to the mid-October deadline.

# (94) TRAFFIC CONGESTION - MCDIARMID DRIVE BETWEEN VICTORIA AND MCTAVISH AVENUES

Councillor Harwood advised that traffic congestion on McDiarmid Drive between Victoria and McTavish Avenues from vehicles entering Tim Horton's continued to be a problem and enquired if stricter enforcement could be considered.

Her Worship the Mayor agreed to take this matter under advisement.

## (95) MAINTENANCE OF PROPERTIES OWNED BY ABSENTEE LANDLORDS

Councillor Harwood advised that he had received a complaint from a ward resident with respect to the lack of maintenance on properties owned by absentee landlords. He enquired if information could be provided on solutions to this problem.

Her Worship the Mayor agreed to take this matter under advisement.

## (96) STATUS OF INFRASTRUCTURE PROJECTS FOR 2011

Councillor Fawcett requested an update on the status of infrastructure projects for 2011.

At the request of Her Worship the Mayor, the City Manager responded that Development Services was working with the Treasury Department to identify projects that could be delayed or altered with an update to be provided at the June 27, 2011 City Council meeting.

#### (97) CIVIC PRIDE CAMPAIGN TO RECOGNIZE WELL-MAINTAINED PROPERTIES

Councillor Roberts noted that while some properties throughout the City of Brandon were unsightly, there were also many well-maintained properties and enquired if a civic pride campaign to recognize such properties could be considered.

Her Worship the Mayor agreed to take this matter under advisement.

## (98) <u>DRAINAGE PROBLEMS IN GREEN ACRES WARD</u>

Councillor Chaboyer advised that she had raised many enquiries in recent weeks with respect to drainage problems in the Green Acres Ward and thanked city staff for their quick responses in alleviating same.

## (99) <u>SPEEDING TRAFFIC ON 1ST STREET</u>

Councillor Chaboyer noted that she had received complaints recently with respect to vehicles speeding on 1st Street. She advised that she had spoken with the appropriate city department and that a 3-way stop sign was being considered at the intersection of 1st Street and Aberdeen Avenue to alleviate this problem.

## (100) SHORTCUT BETWEEN PROPERTIES - 6TH STREET AND ABERDEEN AVENUE

Councillor Chaboyer referred to a shortcut between properties located at 6th Street and Aberdeen Avenue and noted that while the shortcut was city-owned property, pedestrians accessing same were trespassing on private property. She advised that same had since been blocked off by city staff.

## (101) GROWTH OF CITY - ECONOMIC SUMMIT

Councillor Chaboyer referred to the strategic planning session held in March 2011 and requested an update on the proposed economic summit discussed at that time.

At the request of Her Worship the Mayor, the City Manager responded that Administration had begun discussions on the issue of their vision for Brandon and further updates would be provided as the process moved along.

Further to this issue, Her Worship the Mayor added that this topic had been discussed at the recent Federation of Canadian Municipalities Conference in Halifax, Nova Scotia with particular references made as to how economic summits could be used to kick-start economies by providing a focus and direction. Her Worship the Mayor also advised that she would be speaking with the City of Brandon Economic Development Officer with respect to this issue in the near future and agreed to keep City Council apprised of the outcome of that discussion.

#### (102) FUTURE AND CLEAN-UP OF THE DIKE

Councillor Blight requested an update on the future and clean-up of the dike.

At the request of Her Worship the Mayor, the General Manager of Development Services responded that the City was currently working with the contractor to build a road to allow city crews to access the leaking manhole in need of repair, following which an assessment of the dike was expected to take place. He added that necessary improvements to the dike were to be considered as part of the report to City Council at the June 27, 2011 meeting with respect to 2012 infrastructure projects.

#### (101) VARIOUS VICTORIA WARD ISSUES

Councillor Blight advised that he had raised the following Victoria Ward issues with Administration, all of which had been responded to: the Wheat City Golf Course; the City of Brandon Compost Program; tree removal; garbage receptacles; the proposed restrictions on smoking in public places in the City of Brandon; and street cleaning.

## (102) FUNDING FROM PROVINCE OF MANITOBA FOR FLOOD REMEDIATION

Councillor Montague requested an update on the expected funding from the Province of Manitoba with respect to flood remediation.

Her Worship the Mayor responded that the specifics of the proposed grant money have not yet been finalized. She agreed to provide the information to City Council as soon as it was received.

## FUNDRAISING BARBEQUE - EAST END COMMUNITY CENTRE

Councillor Isleifson announced that the East End Community Centre had recently held a barbeque at which over \$800 had been raised for the Red Cross Flood Relief Fund.

## NEW PRESIDENT OF BRANDON CHAMBER OF COMMERCE

Councillor Fawcett congratulated Mr. Cam Clark, General Manager of CKLQ and Star FM Radio, on his recent appointment as the President of the Brandon Chamber of Commerce. Councillor Fawcett also thanked the outgoing president, Mr. P.J. Crane, for his work over the past year.

## GRAND OPENING OF KRISTOPHER CAMPBELL MEMORIAL SKATE PLAZA

Councillor Roberts announced that the grand opening of the Kristopher Campbell Memorial Skate Plaza would be held Saturday, June 18, 2011 from Noon until 4:00 p.m. with the rain date being Sunday, June 19, 2011. He encouraged everyone to come out.
