ADOPTION OF AGENDA:

Mr. Berry advised that the memorial would serve to recognize service people from the Brandon area who had served Canada in times of war and peace. He provided an illustration to show the location and design of the monument and noted that same would be paid for through fundraising efforts, with a dedication ceremony planned for June, 2012.

Herb Mahood, of Manitoba Infrastructure and Transportation, appeared before City Council to provide information on the proposed permanent flood protection for 18th Street North and 1st Street North. He noted that these major roadways would be protected with approximately $3\frac{1}{2}$ kilometers of additional earthern dikes that would hopefully eliminate the need for the super sandbags in the event of future flooding. Mr. Mahood advised that construction was anticipated to begin later this fall.

(A) ACCOMMODATION TAX TASK FORCE

OCTOBER 24, 2011

October 24, 2011 Brandon, Manitoba

Mayor and Councillors City of Brandon

Your Accommodation Tax Task Force conducted a number of meetings and met on October 21, 2011 and wishes to report and submit a recommendation as follows:

Accommodation Tax Task Force Members: Shawn Berry, Committee Chair and Councillor Linden Lanes Ward; Murray Blight, Councillor Victoria Ward; Jan Chaboyer, Councillor Green Acres Ward; Scott Hildebrand, City Manager; Dean Hammond, City Treasurer; Sandy Trudel, City Director of Economic Development; Kevin Swark, Genesis Hospitality; Charlene Harris, Canad Inns; Darlene Janssen, Comfort Inn; Lois McDonald, Riverbank Discovery Centre/Brandon Tourism; Nathan Peto/Cam Clark, Chamber of Commerce.

At the May 9, 2011 meeting of City Council, a motion was passed to establish a Task Force to explore the possibility of implementing an accommodation tax in the City of Brandon to support events and/or initiatives in the areas of economic development, culture and recreation within the city. The Task Force was formed with the intent of possibly bringing forth a recommendation to City Council as to whether the City of Brandon should have an accommodation tax on overnight accommodation for people staying at businesses that offer this type of service in the City of Brandon. The Task Force was formed at the request of Her Worship the Mayor and with the intent of having a wide range of discussion and opinions from people in the hotel industry, tourism, economic development, Chamber of Commerce and City of Brandon Councillors and senior management.

The accommodation/hotel tax has been visited by previous City Councils of Brandon in 2001 in which an enquiry was made, in 2004 at which time a vote to impose such a tax ended in a tie, in 2006 in which such a vote resulted in the motion being defeated, and an enquiry made in 2008 with respect to establishing a hotel tax in Brandon. The proposal to re-visit the possibility of an accommodation tax in Brandon was brought forth by me. Her Worship Mayor Shari Decter Hirst suggested that a Task Force be formed to have inclusion from the hotel industry and other stakeholders in the city to meet and look at possibly bringing forth a recommendation from this Task Force to City Council at a future date.

The Task Force met several times between May and October and invited several people from various businesses and organizations that this tax could potentially affect to make presentations before the Task Force on June 8 on their position regarding such a tax. Presentations were made by:

Jim Baker - Manitoba Hotel Association Paul Robson - Independent Consultant Erin Brown/Pam Moffatt - Brandon First Dave Carriere - Westman Accommdation Group Jason Kreiser/John Macialek - Keystone Centre Daryl Wolski - Proactive Sports At the end of each presentation, the Task Force had a chance to ask questions of the individuals and groups that made presentations. The minutes from that meeting are available through the City Clerk's Office. Other businesses and organizations that were invited but did not present were:

After meeting a few times in June, it was discussed that in order to move forward on this issue research was required to obtain questions from the Task Force from other cities across Canada and in parts of the U.S. regarding this subject. At the request of the Task Force Chair to the City Clerk's Office, a researcher was made available to contact different cities with our questions and provide a written report.

That report was received and presented to the Task Force on August 25th with information provided from those responses. Of the 42 cities that had been contacted, 24 consented to be a recipient of our discovery questions with 15 actually responding to those questions. Both cities with and without an accommodation tax were contacted with our questionnaire and of proximity in size to Brandon. While the response was lower than we had hoped for, the comment was made to our researcher on occasion that their cities currently do not have an accommodation tax but were looking at it. The full research information and responses are available upon request.

The following recommendation is being put forth by the majority of the Task Force members. However, one of the Task Force members, Kevin Swark of Genesis Hospitality is not in favour of proposed tax as he feels there is a lack of a business plan to back up this recommendation.

This report and recommendation are being put forth by the Task Force after 5 months of several meetings, research acquired through contact with other cities, and inclusion of various stakeholders from the City including hoteliers, tourism, economic development, Chamber of Commerce and the City of Brandon.

The recommendation is based on charging a \$3.00 per room flat rate fee as it produces more revenue than a percentage fee with that fee being reviewed on an annual basis for possible increase in increments. The funds derived from this accommodation tax would be used for event acquisition and retention in the City of Brandon and would be considered for disbursement by application to a committee of City Council and recommendation to City Council for approval. Options were considered with respect to the most appropriate means by which to disburse the funds derived from the tax. It was felt that legislatively, the establishment of a committee of City Council for this purpose would be advisable. If this recommendation is adopted by City Council, the Task Force will continue to meet in order to draft a by-law for the imposition of the accommodation tax for consideration and passage by City Council.

RECOMMENDATION:

That in order to promote and support event acquisition/retention in the City of Brandon, a by-law be prepared in consultation with the Accommodation Tax Task Force to impose a tax comprised of a \$3.00 per room flat rate fee for every hotel room occupied overnight in the City of Brandon subject to an annual review and some limited exceptions whereby:

- (a) the funds derived from imposing such a tax shall be placed in a City of Brandon reserve to be named the Accommodation Tax Reserve Fund;
- (b) the sole purpose of such funds shall be for event acquisition/retention;
- (c) the utilization of such funds would be by application to a committee of City Council for recommendation and approval by City Council in each case; and
- (d) the members of the committee shall be appointed annually by City Council and be comprised of two (2) members of City Council; two (2) hoteliers; one (1) member of Brandon First; one (1) member of the Brandon Chamber of Commerce; the City of Brandon's Director of Economic Development; one (1) member of Brandon Tourism; and one (1) citizen-at-large member.
