MINUTES OF THE SPECIAL MEETING OF CITY COUNCIL HELD ON SATURDAY, DECEMBER 10, 2011 AT 9:00 AM IN THE COUNCIL CHAMBER, CIVIC ADMINISTRATION BUILDING, BRANDON, MANITOBA

READING OF THE CALL

At the direction of the Chair, the City Clerk read the following:

"Your Worship, notice of this meeting was provided to all members of City Council advising that a Special Meeting of City Council would be held this date to deliberate the City's 2012 Operating and Capital Budgets."

The City Clerk confirmed that in view of the above compliance and there being a quorum. it was lawful to proceed with this Special Meeting.

GENERAL BUSINESS:

(A) 2012 BUDGET DELIBERATIONS

Blight-McCrae

403 That the 2012 Operating and Capital budgets be approved,

and further, that Administration prepare the required Financial Plan in accordance with the above noted budgets. CARRIED AS AMENDED

It was noted further in the meeting that motions were being made to amend the budget to either delete or reduce expenditures and in some cases, defer the expenditures to the 2013 budget year. The City Clerk explained that such motions could only state a deletion or reduction to the 2012 Capital or Operating budgets. He indicated that the suggestion to defer the expenditure to the following budget year would be duly noted by the attending City Manager and the General Managers of Corporate Services, Development Services and Operational Services respectively for their departments' consideration when preparing their 2013 budgets.

That the main motion be amended by adding following the words: "be approved", the words: "subject to:

(1) the deletion of \$50,000 as an Operating budget expense for sculptures." CARRIED.

That a by-law be prepared to establish a reserve for Youth Programming whereby an allocation of \$100,000 be made from the 2012 budget. LOST.

CARRIED.

"(17) the start date of the Environmental Coordinator be delayed." WITHDRAWN.

 - "(17) The reduction of the allocation for the Community Planner as an Operating budget expense from \$67,817 to \$62,165." CARRIED AS AMENDED.

That the above amending motion be amended by deleting the figure: "\$62,165" and substituting therefor the figure: "\$39,560". CARRIED.

"(18) the reduction of the allocation for the Heritage Coordinator position as an Operating budget expense from \$60,000 to \$30,000." WITHDRAWN.

- 424 That the above main motion be further amended by adding the following sub-paragraph thereto:
 - "(18) the addition of \$27,500 as a Capital budget expense to be funded from the Office Equipment Reserve Fund for the City View cashiering module, and \$1,000 as an Operating budget expense for the associated licensing and software fees." CARRIED.

That the above main motion be further amended by adding the following sub-paragraph thereto:

"(20) the addition of \$32,130 as a Capital budget expense to be funded from the Office Equipment Reserve Fund for portal access, and \$2,813 as an Operating budget expense for annual software fees." CARRIED.

That the above amending motion be further amended by deleting the figure:"\$431,972" and substituting therefor the figure: "\$250,000". CARRIED.

 - "(22) the addition of \$388,000 as an Operating budget expense for drainage, sidewalk and street resurfacing infrastructure projects." CARRIED AS AMENDED.

That the above amending motion be amended by deleting the figure: "\$388,000" and substituting therefor the figure: "\$500,000". CARRIED.

Decter Hirst-Montague

That the motion by Her Worship Mayor Decter Hirst to add \$388,000 as an Operating budget expense for infrastructure and the amended motion by Councillor Berry to increase said amount from \$388,000 to \$500,000 be tabled and dealt with following the intended motion to by Councillor Berry to reduce the appropriations to certain Reserve Funds. CARRIED.

Berry/McCrae

- That the above main motion be further amended by adding the following sub-paragraph thereto:
 - "(23) the deletion of \$150,000 as an Operating budget expense for the following reserve fund appropriations:

Office Equipment Reserve - \$50,000 Recreation Centre Reserve - \$50,000 Sportsplex Reserve - \$50,000." LOST.

In City Council concluding its deliberations, it was noted that the above changes in the budgets, as presented, resulted in a mill rate increase of 5.28%.
